Narrative:

On Tuesday, February 14, 2012, I, Deputy B. Luce, Unit 44E70, of the Harris County Sheriff's Office was dispatched to 2111 Blindlake Dr in reference to a family disturbance.

Upon arrival, I met with complainant, Lisa Kelly, who was identified by her Texas driver's license # Ms. Kenny advised me of the following: Ms. Kenny and her soon to be ex-husband, identified to be suspect, Bill Kenny, are currently separated. She advised they are currently getting a divorce but it has not been finalized. Ms. Kenny advised on this date at approximately 1600 hours Suspect Kenny came to their residence so they could separate some of the pictures of the family. Ms. Kenny advised while separating the pictures the two got into a verbal argument. She advised during the argument she shoved Suspect Kenny in an attempted to get her pictures back. She advised Suspect Kenny the grabbed her by her shirt and shoved her away. He then entered his vehicle and left the scene. Ms. Kenny contacted her father in law who contacted the Sheriff's Office.

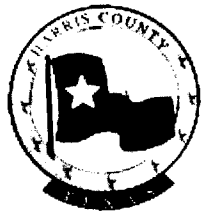

In that interview Mr. Kenny stated that his wife became upset with him for taking his photos from the wall of there residence that he shared with his wife. He stated that he was bitten and scratched over his body by his and that the injuries were observed by his brother(Joe) and a friend Janet Padilla. He stated that he did not have there contact number with him but would get them to me. He stated also that his 15 year old son was at the residence when he was assaulted as well.

He also provided seven photos that were downloaded into this supplements E-file of the injuries he stated he received from being assaulted by his wife on 02/14/12. These photos were taken from his camera phone the day of the assault.

Mr. Kenny also provided a two page typed statement stating what he said happen on 02/14/12.
