She mention I'll be speaking to Oscar Burnias (lead investigator) in the future, asked to be transferred she said ok but hung up.

**Mon Aug 10, 2015**

Attended Night Out kickoff ceremony w/Deputy Chief Cannon at Transit Center. Hand delivered letter to expose Major Greenwood criminal actions. He took it and will look in over, asked about the envelope asked if Micro Installers, Inc was my company? Told him yes.

**Tues Aug. 11, 2015**

Called TXAG June Harden (Missed recording) 512-475-4558 confirm receipt of 560033 comments via USPS. – Long conversation with Ms. Harden, the CD ID number is just an assigned number, they just happen to start with 56 and be 6 positions long. She said TXAG could not confirm my source of the data so instead of asking they just ruled against me because I didn't make my case.  
Ms. Harden said she handed my comments over to open records, I asked her who I need to talk to in order to confirm TXAG records are now current. She said they are current gave me her word.

**Thur Aug. 13, 2015**

Called HCSO Chief Cannon (R\_\_) 713-755-7809 status. Asked for Chief Cannon (Christine refuses to put me thru. She now says everything is being directed by HCAO integrity unit).  
Called TXAG (R\_\_) 877-673-6839 Hotline – Have the received my comments for 560033 sent last week and that your records are current. What is the ID# assigned to this version of comments? Who is the records custodian? (missed the call back)

**Wed Aug. 19, 2015**

Sent updated Email to HCAO now with 10 questions.

Called HCDA Scott Durfee (R\_\_) 713-755-5816 confirm receipt of 560033 comments via USPS.

**Holy Cow**, talked to Ms. Goode she said if she received them they are filed with my file. I was looking for conformation and asked who the records custodian is the phone was handed over to Scott and he said my records were held by HCDA/Integrity not the records custodian. I could not get a logical explanation why Integrity unit is holding (**hiding**) my data – now it will never be found on an ordinary search. This cannot be standard procedure!

Called HCDA – asked for records custodian, district clerk office for closed cases.

Called TXAG 877-673-6839 Hotline – Contact information for records custodian for open records.

Called HCDA Public Integrity (R\_\_) 713.755.8330 – have you received the comments I sent to Scott Durfee on Aug 5<sup>th</sup>? Why are you withholding my file, my data from the records custodian? (They did receive my priority mail, no idea why they are holding my data instead of records custodian. Ms. Natalie Witte Tise is now in charge instead of Terese, she is out of office till sept 3th, and I'll call back).
